

Investment Philosophy - Avoid the Human Factor

A common myth is that to generate higher portfolio returns an investor must take on more risk. That is not true at all. Some types of risks result in losses rather than greater returns. The G&L SNN Equity Fund avoids these risks and by doing so increase the return.

The Fund is designed around a unique and proprietary methodology developed by New Age Alpha, LCC that measures investor behaviour risk, called the Human Factor. The Human Factor is the risk that investors have pushed the stock price too high and out of line with management's ability to deliver the performance to support that stock price.

Assessing management's ability to deliver performance to support the price of the stock is critical because it balances the stock price (which is based on investors' biases) and the company's results. If management fails to deliver such results the stock price will drop, and investors will lose money. Investor loss is strongly related to management failing to deliver the results the stock price implies.

There is no benefit of exposure to Human Factor Risk, only cost. This Human Factor Risk is the risk of losing for which investors are not paid for taking.

By avoiding this Human Factor risk, the fund both reduces risk and outperforms. Using both company fundamentals and stock price - both unambiguous pieces of information - allows us to repeatedly and consistently identify stocks likely to underperform. Alpha at that point is as simple as eliminating those high Human-Factor shares from our portfolios.

In addition to the Human-factor, The G&L SNN Equity fund combines other single-factor strategies. These strategies build upon the long-standing concept of diversification: that combining exposures to factors can help soften the effect of drawdowns and increase the potential for outperformance.

The exposure of the fund to the single-factor strategies is quantitatively calculated to optimise the expected return under certain constraints of total risk (absolute volatility) and tracking error (relative volatility). The other single-factor strategies that we combine with the Human Factor are:

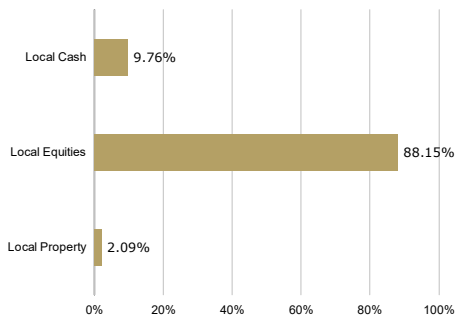
Large capitalisation shares are combined to reduce the tracking error of the fund to the market due to the large weighting of the biggest shares in the market.

Value aims to capture excess returns from stocks that have low prices relative to their fundamental value. The value strategy is tracked by price to book, price to earnings, dividends, and free cash flow.

Momentum shares that have outperformed in the past tend to exhibit strong returns going forward. The momentum strategy uses relative returns from 3 months to a 1-year period.

Quality shares are defined by low debt, stable earnings, consistent asset growth, and strong corporate governance. They are identified through financial metrics like return to equity, debt to equity and earnings variability.

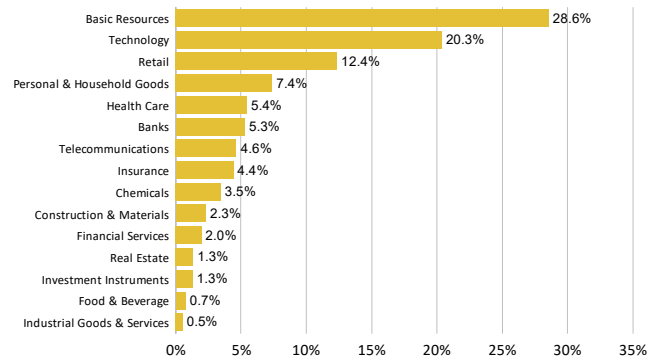

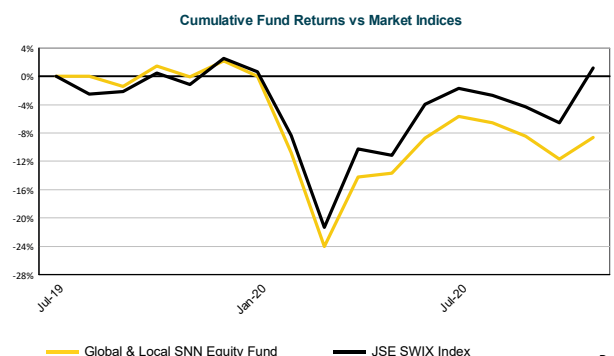
Investment Strategy

The Portfolio is a constructed around a unique and proprietary methodology that measures investor behaviour risk, called the Human Factor. Relative and absolute risk is quantitatively controlled through additional factors including SWIX 40, Value, Momentum and Quality. The portfolio's equity exposure will always exceed 80% of its net asset value.

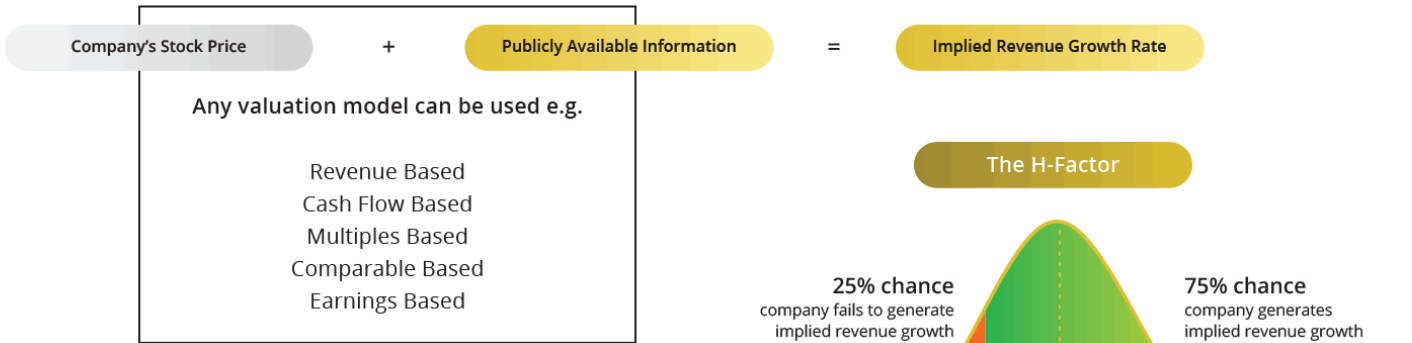
Sector Allocation

The H-Factor



Manage risk like an actuary, not like a portfolio manager.

Using a probability-based approach we seek to identify when The H-Factor (investor biases) has under or overpriced the stock.

Index Construction

The H-Factor System is designed to help you avoid The H-Factor inside your portfolio. This system measures the amount of H-Factor in a stock's price.

In this example Liberty Holdings has a 72.2 H-Factor Score. A 72.2% chance of not delivering there earning to support the stock price. Discovery has a lower H-Factor Score of 4.4%. A 4.4% chance of not delivering the earnings to support the stock price.

Higher H-Factor = Higher Risk of Loss

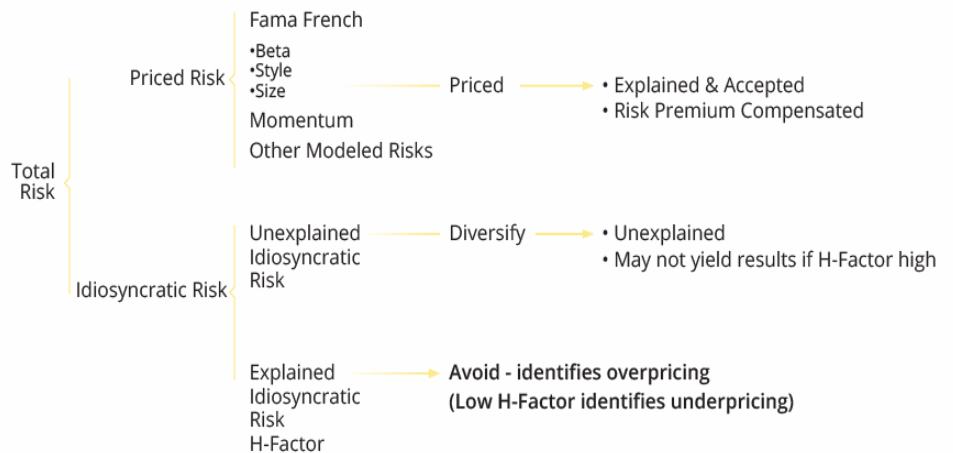


Avoiding The H-Factor is an Innovative Source of Alpha

It's commonly assumed that there are two types of risks, those that are priced, for which investors demand compensation, and those that remain unpriced. Conventional wisdom says to diversify the unpriced portion of the risk when constructing a portfolio. We agree, pure idiosyncratic risk should be diversified away.

We believe the unpriced risk contains more than simply idiosyncratic risk, but rather a combination of idiosyncratic and H-Factor Risk.

However, the H-Factor cannot be diversified away and its presence makes your diversification strategy inefficient. To make your diversification strategy work, you need to identify, measure and AVOID the H-Factor.

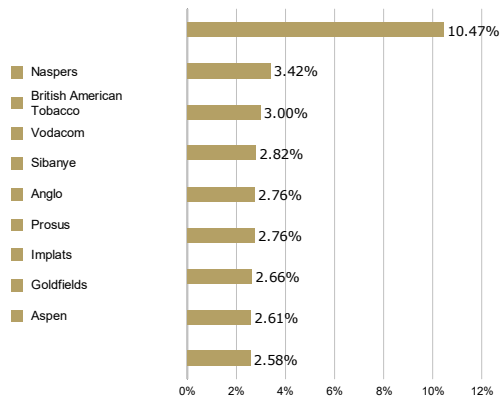

Fund Risk

Volatility Risk:

Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.

Concentration and Sector Risk:

A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.

Equity Risk:

Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Highest & Lowest Return:	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER)	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
