

### Investment Philosophy - Avoid the Human Factor

A common myth is that to generate higher portfolio returns an investor must take on more risk. That is not true at all. Some types of risks result in losses rather than greater returns. The G&L Offshore Equity fund avoids these risks and by doing so increase the return.

The Fund is designed around a unique and proprietary methodology developed by New Age Alpha, LLC that measures investor behaviour risk, called the Human Factor. The Human Factor is the risk that investors have pushed the stock price too high and out of line with management's ability to deliver the performance to support that stock price.

Assessing management's ability to deliver performance to support the price of the stock is critical because it balances the stock price (which is based on investors' biases) and the company's results. If management fails to deliver such results the stock price will drop, and investors will lose money. Investor loss is strongly related to management failing to deliver the results the stock price implies.

There is no benefit of exposure to Human Factor Risk, only cost. This Human Factor Risk is the risk of losing for which investors are not paid for taking.

By avoiding this Human Factor risk, the fund both reduces risk and outperforms. Using both company fundamentals and stock price - both unambiguous pieces of information - allows us to repeatedly and consistently identify stocks likely to underperform. Alpha at that point is as simple as eliminating those high Human-Factor shares from our portfolios.

The G&L Offshore Equity fund is a quantitative fund that allocates exposure to Human Factor strategies, Low Volatility equity strategies and cash over the following regions: U.S. Large-Cap, U.S. Small-Cap, UK, Europe Ex-UK, and Japan.

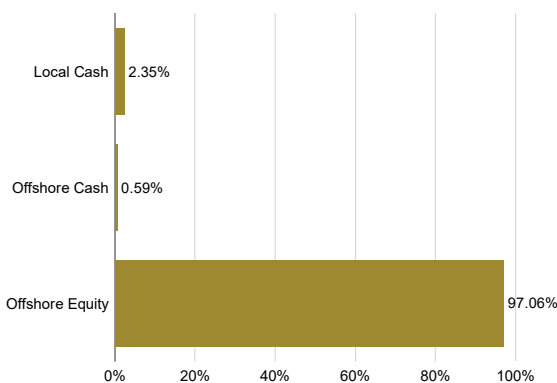
Exposure to each underlying regional risk allocation corresponds to their weights in the benchmark, the S&P BMI Global Developed World Universe.

Within each of the underlying regions, the exposure to Human Factor strategy, Low Volatility equity strategy and cash for that region is determined by respective indicators that reflect market momentum, sentiment and economic strength.

### Investment Strategy

The Portfolio is a quantitative multi-factor focused portfolio. The Portfolio is constructed using the following factors globally: Unpriced Risk and Low Volatility. The Portfolio determines the allocation between US (Large Cap), US (Small Cap), the United Kingdom, Europe (ex-UK) and Japan based on the respective jurisdictions weighting in the S&P Developed BMI (Ticker: SBBMWDU). The portfolio will invest a minimum of 80% of its market value in foreign equities.

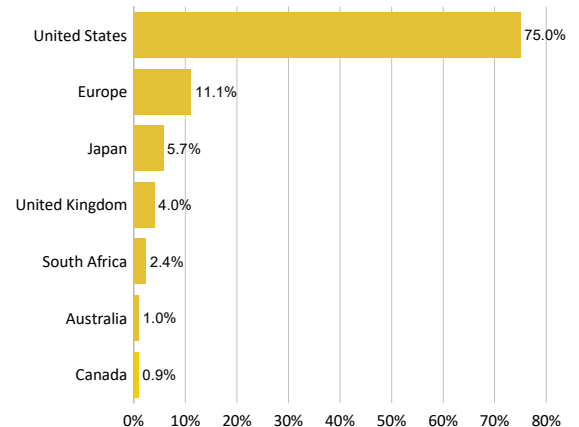

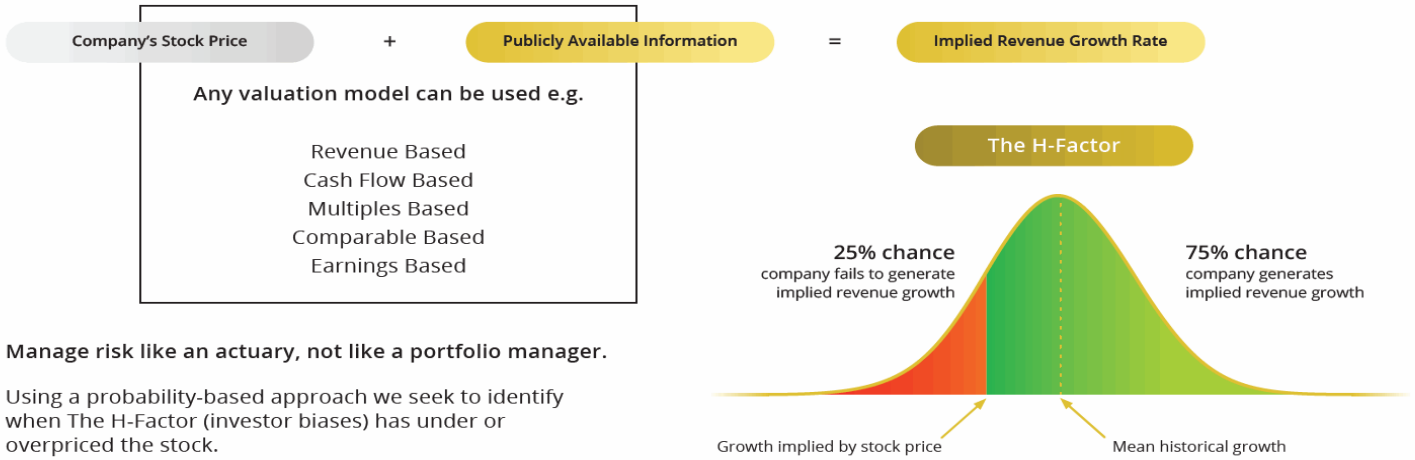
### Portfolio Objective

## The H-Factor



Manage risk like an actuary, not like a portfolio manager.

## Index Construction

The H-Factor System is designed to help you avoid The H-Factor inside your portfolio. This system measures the amount of H-Factor in a stock's price.

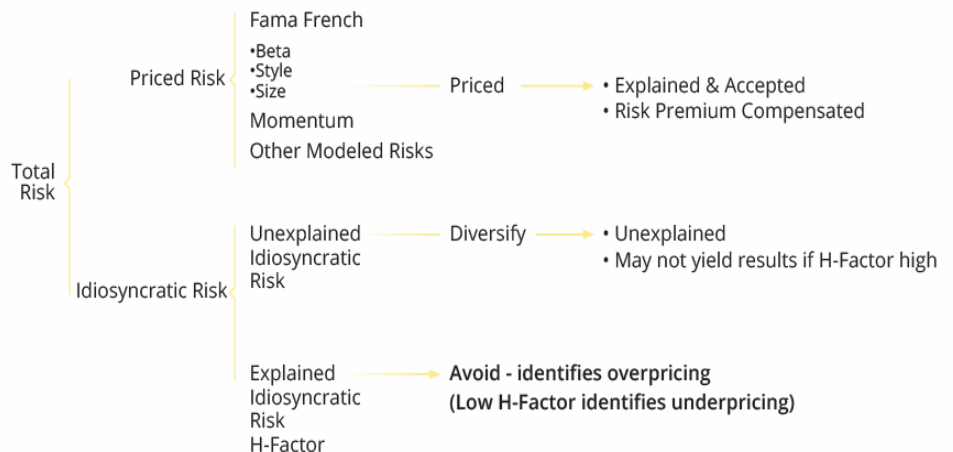


## Avoiding The H-Factor is an Innovative Source of Alpha

It's commonly assumed that there are two types of risks, those that are priced, for which investors demand compensation, and those that remain unpriced. Conventional wisdom says to diversify the unpriced portion of the risk when constructing a portfolio. We agree, pure idiosyncratic risk should be diversified away.

We believe the unpriced risk contains more than simply idiosyncratic risk, but rather a combination of idiosyncratic and H-Factor Risk.

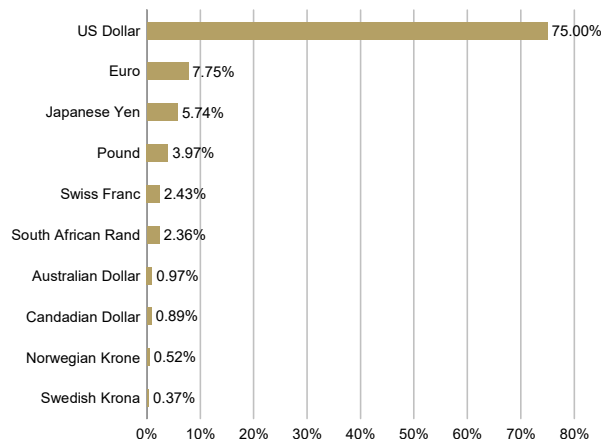
However, the H-Factor cannot be diversified away and its presence makes your diversification strategy inefficient. To make your diversification strategy work, you need to identify, measure and AVOID the H-Factor.

## Fund Risk

<b>Volatility Risk:</b>	Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.
<b>Concentration and Sector Risk:</b>	A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.
<b>Equity Risk:</b>	Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. <b>Standard Deviation/Volatility:</b>	The deviation of the return of the portfolio relative to its average.
